VIC APPRENTICES AND TRAINEES

This list indicates the value of the incentives and benefits you may be eligible for as an apprentice or trainee. It is a guide only. Payment of incentives and benefits will be subject to employers and their apprentices or trainees satisfying the eligibility criteria. Details of each incentive and benefit should be discussed with your Industry Training Consultant.

<p>Trade Support Loan 1300 363 831 Apprenticeship Support Australia Not applicable for NZ Citizens and Non-permanent Visa Holders</p>	<p>From 1 July 2020 eligible apprentices and trainees have access to loans of up to \$21,542 over four years to assist with the costs of completing an apprenticeship or traineeship. Paid in monthly instalments in arrears with annual limits of \$8,617 in year one; \$6,463 in year two; \$4,308 in year three; and \$2,154 in year four. On loan approval, 6 months of monthly instalments become payable. You must opt in for another 6 months of payments to continue the loan. You can opt out at any time and to avoid any overpayment you must advise Apprenticeship Support Australia within 14 days if you leave or are suspended from your apprenticeship/traineeship. Repayments of the loan are made through the tax system and start when you are earning a sustainable income. A list of compulsory repayment thresholds and rates is available at studyassist.gov.au/paying-back-your-loan/loan-repayment The compulsory repayment threshold for the 2020-21 income year is \$46,620. A 20% discount applies to the loan on successful completion of your apprenticeship or traineeship.</p>	
<p>Additional Identified Skills Shortage Payment (AISS) 1300 363 831 Apprenticeship Support Australia</p>	<p>From 1 July 2019 an AISS payment will be available to eligible apprentices in identified occupations experiencing national skill shortages.</p> <ul style="list-style-type: none"> • \$1,000* at the 12 month point from commencement from the apprenticeship/traineeship • \$1,000* after successfully completing the apprenticeship/traineeship <p>* These payments are subject to tax.</p>	
<p>Living Away From Home Allowance (LAFHA) 1300 363 831 Apprenticeship Support Australia</p>	<p>You may be eligible for LAFHA if you have to move away from your parental/guardian home for the first time to commence or remain in an apprenticeship or traineeship.</p>	
<p>Centrelink - Income Support (in lieu of LAFHA) 13 36 33 humanservices.gov.au</p>	<p>ABSTUDY – help with costs if you are an Aboriginal Australian or Torres Strait Islander undertaking an apprenticeship or traineeship or studying and not getting another payment to study or train. Austudy – provides financial support if you are aged 25 years of age or older and a full-time student, apprentice or trainee; and under the income and assets test limits. Youth Allowance – financial help if you are 16 to 24 years of age and undertaking a full-time apprenticeship or traineeship.</p>	
<p>Low Income Health Care Card</p>	<p>Contact the Department of Human Services to check if you are eligible to apply for a Low Income Health Care Card. The card may provide other benefits such as concessions and discounts for training courses (contact your RTO to ask about this).</p>	
<p>Skills First Program - Subsidised Training</p>	<p>Apprentice and trainee (including School-based arrangements) student fees funded under the VIC Government's Skills First Program. Conditions apply. For more information visit: education.vic.gov.au</p>	
<p>Public Transport Concession Card</p>	<p>Concession to travel on public transport in VIC is accepted subject to meeting eligibility criteria. Visit: ptv.vic.gov.au/tickets/myki/concessions-and-free-travel</p>	
<p>Victorian trade apprentice car registration discount</p>	<p>If you're a trade apprentice using your car for work you may be entitled to get 50% off your next registration renewal. Visit: vicroads.vic.gov.au/registration/registration-fees/concessions-and-discounts/trade-apprentice-registration-discount</p>
