| Group Training Additional Apprentice Bonus | Eligible group training organisations will receive a \$5,000 bonus payment for each new full-time apprentice commencement in excess of the number of commencements of previous years. | Payroll tax exemptions | Wages paid to apprentices and new entrant trainees may be exempt from payroll tax. For details call Queensland Treasury, Office of State Revenue on 1300 300 734 |
| School to Trade Pathway Incentive | Private and public sector employers may be eligible for a \$5,000 bonus payment if they commence a school-based apprentice on or after 1 July 2013, which is then converted to a full-time arrangement.
