

Apprenticeship Support Australia Survey Competition

The competition organiser is Chambers Apprenticeship Support Australia Pty Limited (ABN 51 602 702 796) trading as Apprenticeship Support Australia (**ASA**).

Competition period

The competition will run from 12:01am AEST on Tuesday 11 November 2025 until 11:59pm AEST on Monday 8 December 2025 (**Competition Period**).

Eligibility to enter: This competition is open to Apprentices and Trainees who are currently registered or previously registered with Apprenticeship Support Australia as their Apprentice Connect Australia Provider, who, during the Competition Period, complete the *Apprenticeship Support Australia First Year Experience Survey* form on or before the end of the Competition Period (**Eligible Participant**). Only one entry per person is permitted. Incomplete or duplicate entries will be disqualified.

Draw details

- One main winner from the survey will receive a \$1000 eftpos gift voucher
- An additional two secondary winners will each receive a \$250 eftpos gift voucher.
- Eligible Participants will be entered into a random draw upon completing the form and opting in for a chance to win of the three above prizes.
- Three prize winners will be selected by random draw.
- The first \$250 voucher prize will be drawn on 17 November at 12:00pm AEST at Level 7, 8 Chifley Square, Sydney, NSW 2000 from participants who have completed the form to date.
